**3.** By signing this contract and leaving my dog(s) with the resort/kennel, I certify to the accuracy of all information given about the said dog(s).

**4.** I further understand and agree that in admitting my dog(s) to Furball Fitness Daycare, Resort & Spa, staff have relied on my representation that my dog(s) is/are in good health and have not harmed or shown aggressive or threatening behavior towards any person or any other dog. I hereby indemnify Furball Fitness Daycare, Resort and Spa, LLC, it owners and representatives, with regard to any claims arising from the aggressive behavior of my dog.

5. I agree that Furball Fitness Daycare, Resort and Spa, LLC, will not be responsible or liable for lost, stolen or damage to personal property belonging to me.

**6.** I understand and agree that Furball Fitness Daycare, Resort and Spa, LLC and their staff and volunteers, will not be liable for any problems which develop, including but not limited to, loss by fire, theft, running away, death or injury, and I hereby release and discharge Furball Fitness Daycare, Resort and Spa, LLC, its owners, employees and representatives from any and all claims, damages, liability and/or causes of action of any kind arising from my dog(s) attendance at the kennel except where any such loss is caused by negligent or intentional act of an employee or representative of the resort/kennel.

I specifically represent to Furball Fitness Daycare, Resort and Spa, LLC, that the dog(s) have not been exposed to rabies or distemper within a 30 day period prior to boarding and that the dog(s) has all the necessary vaccinations (Rabies, Distemper (DHLPP) and Bordetella). Evidence of these vaccinations has been provided at time of lodging/boarding.

**8.** I understand that the dog(s) must be treated for fleas and ticks prior to arrival. If fleas or ticks are found on the dog(s) during lodging/boarding the staff of Furball Fitness Daycare, Resort and Spa, LLC, will treat the dog(s) at the owners expense.

**9.** All charges incurred shall be payable upon pickup of dog(s), or when billed by the resort/kennel at address listed on contract. The resort/kennel shall have and is hereby granted a lien on the dog(s) for any and all unpaid charges resulting from lodging/boarding dog(s) at the resort/kennel.

**10.** Furball Fitness Daycare, Resort and Spa, LLC, will make every effort to keep all dogs safe however I recognize that there are inherent risks of illness or injury when dealing with animals. Such risks include, but are not limited to problems resulting from rough play and canine cough.
